What is the Federally required DBE program?

- The <u>Disadvantaged Business Enterprise Program (DBE)</u> is a legislatively mandated USDOT program that applies to Federal-aid highway dollars expended on federally-assisted contracts issued by USDOT recipients such as State Transportation Agencies (STAs). The U.S. Congress established the DBE program in 1982 to:
- I. Ensure nondiscrimination in the award and administration of DOTassisted contracts.
- II. Help remove barriers to the participation of DBEs in DOT-assisted contracts, and
- III. Assist the development of firms that can compete successfully in the marketplace outside of the DBE program.
