# What is HB 2017?

## HB 2017 & STIF

- HB 2017 Keep Oregon Moving Act
- Statewide Transportation Improvement Fund (STIF)

## Employee payroll tax

- 1/10<sup>th</sup> of 1 percent of all payroll statewide
- 90% of funds in TriMet's district comes back to TriMet

## TriMet is the “Qualified Entity” for the 3-county area

- Pass funds through to the counties and small transit providers outside the TriMet area



# STIF Plan

## In order to receive STIF funds:

- Develop a STIF plan
  - Currently in the FY26-27 biennium
  - Committee will work on the plan for the FY28-29 biennium
  - TriMet district and non-TriMet district funds

## Citizen Advisory Committee

- 22 member committee representing customers, underserved communities,\* transit providers,\* seniors & people with disabilities,\* business associations, and jurisdictions
- TriMet Board of Directors appoints the committee and approves bylaws
- Meet twice/year; more often in plan development years
- Approve the *Public Transportation Improvement Plan (PTIP)*




# STIF Legislation

## Focus:

- Expansion of bus routes and service to low-income areas
- Increased Frequency to low-income areas
- Natural gas or electric buses
- Fare reduction for low-income communities
- Improved connections inside/outside districts
- Reduced fragmentation of services
- 1% of funds spent on student transportation
- Enhance services for older adults and people with disabilities

# STIF Pay vs STIF Pop

## STIF Payroll Based Formula Funds (STIF Pay):

- Funds derived from the 0.1% payroll tax
- Allocated based on where payroll is generated
- Can't be used for light rail capital investments

## STIF Population Based Formula Funds (STIF Pop):

- Funds derived from cigarette tax, ID card fees, non-auto. gas tax, & STIF Pay funds
- Transportation programs for older adults and people with disabilities




# Decision Making Process




# Committee Voting Process

- Committee Chair calls for a motion
- Member makes a motion
- Member seconds the motion
- Committee Chair calls for discussion
- During discussion a member can ask to amend the motion
- If the member who made the motion accepts, then
  - the Committee Chair seeks a second
  - if seconded, the Committee Chair calls for discussion
- If the member denies the amendment, then the Chair calls a vote on the original motion after discussion
- Committee votes



# 2025 Compliance Report

OR 732-040-0030(4)(a) – Adopted bylaws must include:

- Committee's name and purpose ✓
- The number of committee members ✓
- Committee membership criteria ✓
- The appointment process ✓
- The terms of office for the committee members ✓
- The committee meeting schedule ✓
- Committee procedures and member duties, including procedures to provide public notice to foster community engagement and comply with Oregon public meeting and public records law ✓
- The committee's process to review PTSPs' proposals for projects X

# Proposed Bylaw Changes

## Add a new section to Section “X. Eligible Projects and Process”

- C. The Advisory Committee shall consider the following when reviewing STIF Forumla Fund Projects:
  - i. The extent to which the project is eligible per the eligible projects listed under X.A.i. through X.A. ix;
  - ii. Whether the project would maintain an existing service;
  - iii. The extent to which the project goals meet public transportation needs and are a responsible use of public funds;
  - iv. The extent to which the project might benefit or burden historically or currently marginalized communities both now and in the long-term; and
  - v. Other factors to be determined by the Qualified Entity or Advisory Committee.

# Proposed Bylaw Changes

## Bylaw cleanup suggestions:

### III. Committee Operations

D. “Committee votes will be the prevailing decision making procedure used at meetings”

***Replaces a consensus decision making process with a vote***

### VI. Committee Membership

D. “At a minimum the committee must have members that represent:”

***Add “Public Transportation Service Provider”***

### X. Eligible Projects and Process

A. “...Projects eligible for funding in the plan include:”

***Add A.xi. “and the preservation of existing transit operations.”***

B. “...the committee will review, discuss, revise if needed and approve:”

***Add “X.A.i through X.A.xi” to sections XI.B.iv and XI.B.V***
